# Centralized Admission NUMS Private Sector Medical & Dental Colleges First Year MBBS and BDS Session 2023-24 How to Apply:

- a. Choose the link to apply for Private Sector Medical & Dental Colleges.
- b. Login with same CNIC/B Form/NICOP/Passport Number and Password as with which candidate registered for MDCAT (NUMS)-2023 (Held on Sunday, 03 September 2023)
- c. Applicants who want to apply on the basis of MCAT (USA) /UCAT (UK) for foreign seat will have to register themselves on Online Admission Portal to process the application.
- **d.** After Login, applicant is required to complete application form:
  - a. Personal/Profile Information and Academic Information
  - b. Test Information and Institute/Program Choices (MBBS/BDS) will be auto selected.
  - c. Upload Original Scanned Documents
  - d. Download Fee Challan

Print Admission Processing fee challan @ Rs 5,000 (For Open Merit Seat) / Rs 30,000 (For Foreign Seat) Non-refundable/Non-transferable which can be deposited at any branch of Habib Bank Ltd by or before Friday, 27 October 2023 by 1600 hours

- e. After payment, upload Paid Fee Challan
- f. Preview and Submit Application.
- e. Applicants can only apply by using desktop PC or laptop Only.

## For Foreign Seat:

- a. Recent coloured passport size photograph of the applicant with blue background.
- a. Current valid NICOP/Passport of the candidate.
- b. Current Valid NICOP/Passport of Father/Guardian.
- c. Candidate will render a certificate from the institution last attended confirming last two years of schooling from abroad.
- d. Matric/SSC Certificate or result card issued by concerned BISE or Foreign Institute (must be IBCC attested) /Equivalence Certificate of O-Level/10th grade etc., issued by IBCC.
- e. F.Sc/HSSC Pre-Medical result card issued by concerned BISE or Foreign Institute (must be IBCC attested) /Equivalence Certificate of A-Level/12th Grade, etc. issued by IBCC.
- f. Transcripts of 10th Grade/O Level, where applicable.
- g. Transcripts of 12th Grade/A-Level, where applicable.
- h. NUMS copy of paid Admission Application Processing Fee Challan.
- i. Result of MDCAT (NUMS)-2023 (Held on Sunday, 03 September 2023) /Valid MCAT (USA)/Valid UCAT(UK), where applicable
- j. Duly signed and scanned Undertaking on plain paper.

# **Process of Generating Merit List:**

- a. NUMS will generate a complete merit list for each college and forward to all its respective affiliated and attached Medical and Dental Colleges.
- b. Each affiliated and attached Medical/Dental College will display its complete merit list on their website and notice board as well.
- c. College will make admissions on allocated seats while adhering strictly to merit, as provided by NUMS.
- d. College will inform each applicant who are in merit list (as per sequence of aggregate merit) via email and telephone and will also keep record of that correspondence with each applicant as a documentary evidence for reference.
- e. When a student accepts admission to a College, he/she must disclose to that college, of the provision offer as well as acceptance of admission to other College. Before accepting the later admission, the student must notify the first College in writing of cancellation of the previous acceptance. Failure to cancel acceptance of prior admission offer will render all admission offer as void and he/she will become ineligible for admission.

### **IMPORTANT**

a. Possession of CNIC is mandatory for students aged 18 and above at the time of admission.

- b. Candidates having O-Level/10th Grade and A-Level/12th Grade Level etc. shall have to upload the equivalence certificate issued by IBCC at the time of submission of online application, otherwise their application shall be rejected.
- c. It shall be the sole responsibility of the candidate to submit complete application along with the required documents. Application once submitted, cannot be changed by the applicant. Candidates are advised to be careful while filling the Online Application Form. In case of any deficiency, the University may reject the application without intimation to the candidate.
- d. The university shall cancel any provisional admission where the credentials of a student are not verified
- e. **Applications shall be submitted through online portal only.** Hard copies are not acceptable.
- f. Applications for improved results of FSc/HSSC/A-Level/12th Grade will be entertained till 10 November 2023 only.
